Eligibility & Copyright Consent Statement

- 1. The consenter agrees to grant the Implementation Committee for the "Argo Island Villa International Design Competition" and Taiwan Architecture Magazine the right to use the images of his/her/its competition work (including but not limited to photos, design drawings, pictures) gratis for the following purposes:
 - a. Publicly publish and promote the work in various online, print or TV media, and carry out digital archiving, reproduction, public transmission over the Internet, printing, browsing, etc.
 - b. All preliminary-round nominees agree to unconditionally provide the drawing data needed for the exhibitions and special publications of the event, and cooperate with marketing promotional approaches by allowing the works' images to be included in a database for services. - 2. Contestants being selected in the final round shall be separately provided with an operating fee of NT\$600,000 by the Organizer (Party A) for them "to complete the application for Construction License and Construction Drawings (structure, water and electricity) in accordance with relevant construction and architectural regulations, and to perform the obligations and duties required of a statutory supervisor."
- 3. For a contestant who is not an architect registered and running an architectural business in the Republic of China (Party B) or those who are not a citizen of the Republic of China (Party B), the abovementioned tasks shall be performed by an architect (Party C) selected by the said contestant, or an architect (Party C) offered by the Organizer, with whom the contestant shall cooperate. The relevant fees shall be negotiated by both parties (Party B and Party C) themselves.
- 4. The consenter guarantees that he/she/it is entitled to the right to perform the authorizations specified in this Consent Statement, and guarantees that the authorized work images do not infringe on the intellectual property or other rights of any third party. The consenter shall be solely responsible for the disputes, if any. This Consent Statement is a non-exclusive license. The consenter still has the right to authorize other parties to use his/her/its work images.
- 5. The consenter declares that his/her/its identity status complies with the competition rules. If there is any identity non-compliance identified after investigation, the Organizer has the right to cancel the consenter's participation eligibility, nomination eligibility, or winning eligibility.
